Red Oak Pipeline LLC, a 50/50 joint venture between Phillips 66 Project Development Inc. and Plains Pipeline, L.P. (Plains), will be proceeding with construction of the Red Oak Pipeline System (Red Oak) first quarter 2021. Plains Pipeline, L.P., P5 # 667884 is the construction manager for the pipeline and will be constructing the pipeline for the joint venture. The pipeline will provide crude oil service from Cushing, Oklahoma to Corpus Christi, Ingleside, Taft, Channelview, and Beaumont, Texas.

Required shapefiles, a required sworn statement confirming classification as common carrier, and an Overview map are included in this submission. Additionally, five PS48s have been submitted to POPS separately. Until a new T-4 permit number is assigned by the RRC, I have designated the T4 permit number as "t00000".
